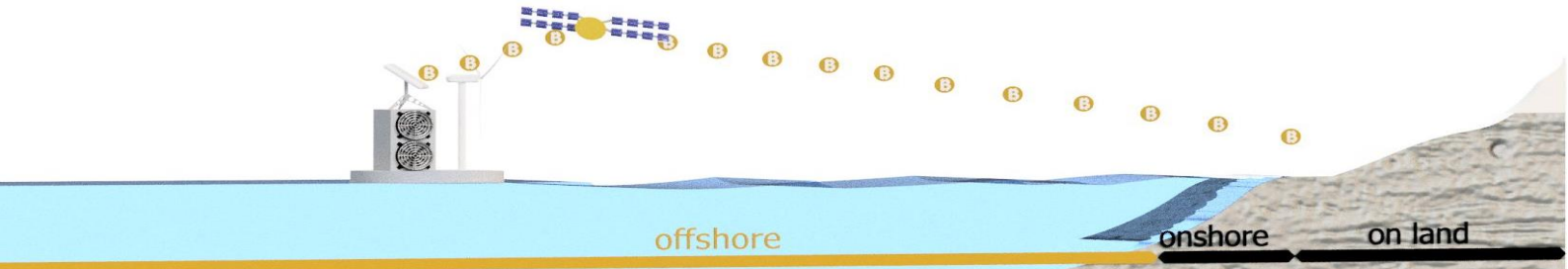

Moreover, offshorecoin's idea will improve the demand of various offshore energy technologies to mint crypto currencies but reduce more carbon foot prints in next years.

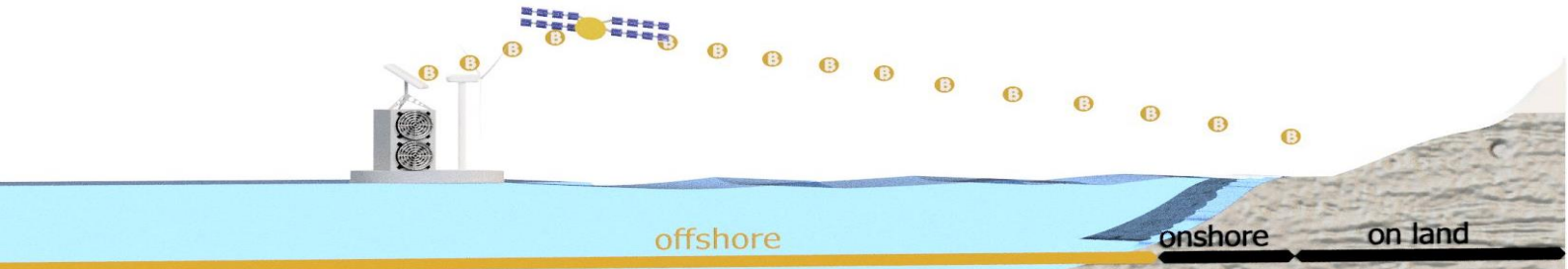
2. Market

Offshorecoin will invest in offshore energy technologies.

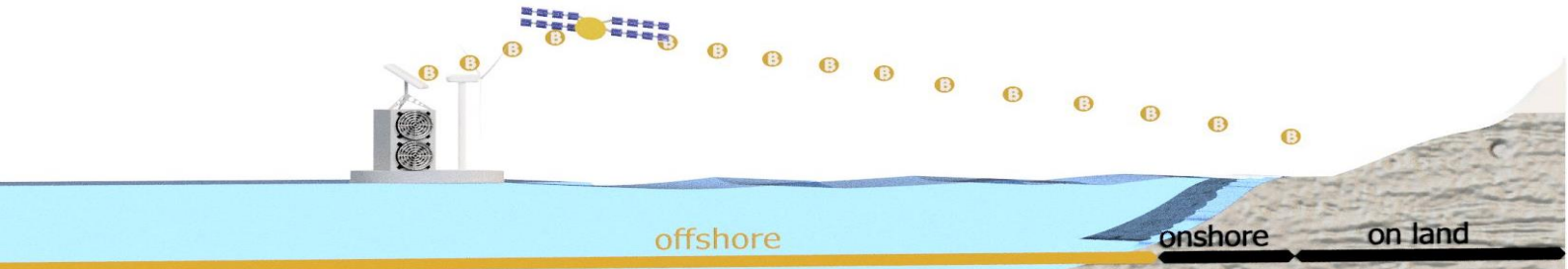
Offshorecoin create privileges for businesses that admit this token for their trade and motivates all companies, regardless of their size, to become greener in a profitable way.

3.2.5.Privileges to Satellite Internet Services

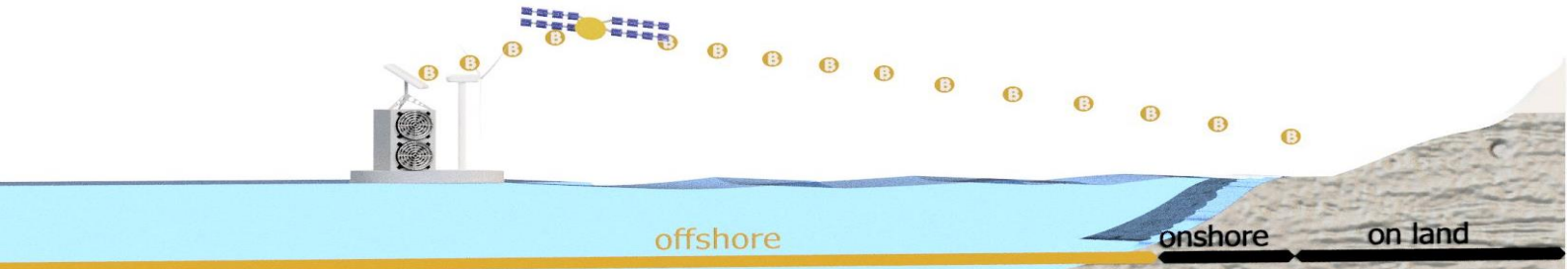
Offshore area has a population density near zero. It means that satellite internet providers will gain new paying customers of their service and hardware in offshore water surfaces.

6.1. Airdrops

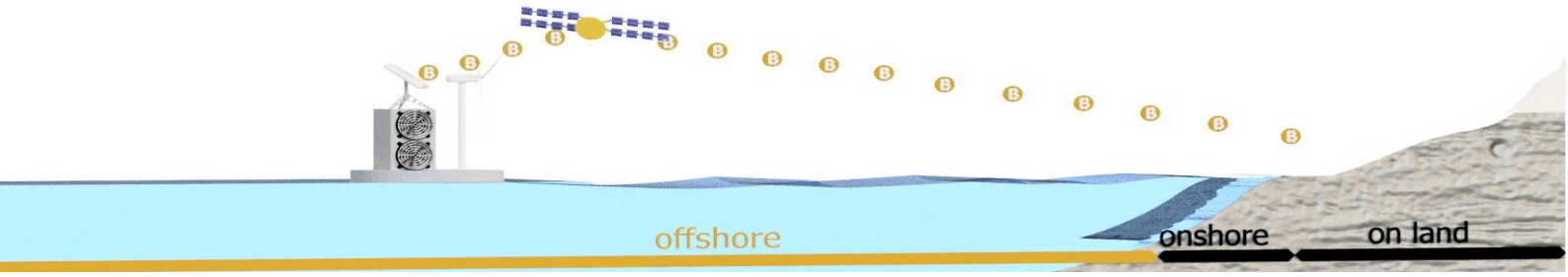
Offshore token price is fixed in normal exchange. Monthly airdrops will be announced on offshorecoin social network pages.
